University) (hereinafter referred to as party of the Second Part or Second party).

(First Party and Second Party are hereinafter jointly referred to as 'Parties')

The Purpose of this Memorandum of Understanding (hereinafter called as the 'MoU') is that the two Parties will take up various computer education activities, to Provide Expert Lectures on relevant subjects and exchange knowledge based on mutual cooperation and understanding.

The both Parties after due considerations of various aspects have arrived at the following understanding in respect of dissemination of academic knowledge, participation in various educational programmes:-

1. Mahatma Gandhi Vidyamandir's Samajshree Prashantdada Hiray Arts, Science and Commerce College Nampur (First Party) will provide their students and staff for successful completion of the different activities.
2. The parties will evolve a mechanism for exchange of experiences and expertise for mutual benefits of both.
3. The expenses incurred on any activity will be borne by the First party. The other partner will be immune from any such financial liability.
4. Any other point which is not covered under this MoU but may be mutually beneficial and agreed upon for by both the parties.
5. This MoU shall be construed as a purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this MoU shall create any legal relationship between the Parties.
6. This agreement will take effect from the date of its signing and shall be valid for a period of five years. However, the Agreement may be terminated before the expiry of the period of Five years by three months' notice in writing delivered by any party to the other.
7. The Parties are hereby agreed to establish mutual association on aforesaid areas.
